

 - Operating Expenses (2%)
 - This is for the website & platform, and insurance
 - Misc. Expenses (11%)
 - This covers Teacher Appreciation, any printing expenses
 - Education (60%)
 - 4 Main Drivers
 - SODE Dance Program
 - DramaWorks
 - Music
 - Gardening

Questions

- How much money is in the PATT reserve?
 - o roughly 140K
- SODE Dance Program is a huge amount of money, did we get other bids?
 - Mrs. Desiderio found that the program is really the best
 - Other programs were only working with a certain grade
 - They are working with ALL of our classes
 - Many different employees come out to help and teach the kids
 - Mr. Wright also jumped in and explained that this is a supplemented curriculum, and our teachers have been training with Jonas
 - The curriculum takes time and effort and this costs money
 - The teachers are using the different techniques (such as dramaworks) in the classroom
 - Quality costs money
- Is there a way to have a poll for more programs? This is in the case a child does not like dance and would rather do drama
- Is Mr. Grueschow a part of SODE?
 - He is under SODE for insurance reasons
 - This is the new LAUSD sexual abuse and molestation insurance
- The new sexual abuse and molestation insurance is so expensive, are there other insurers that can be used?
 - This insurance is only for LAUSD locations, so for some events like Glow Dance that aren't on LAUSD property this insurance isn't needed.
 - Another solution was that PATT paid DJ Colby's portion of the insurance because we know we will be using him for other events
- A parent mentioned her daughter wanted to join the dance program last Spring but was turned away because it was too full
 - This is different from the SODE dance program, that was for the talent show and for that there were a specific number of spots
 - Every student gets the SODE dance program
- Does PATT money go to facility updates?
 - There is a district plan for the playground updates
- Specifics on the dance program?
 - Parent was inquiring on an invoice or any paperwork to show the breakdown
 - Also wanted to know the amount of teachers that SODE would provide
- How does WHECES pay for aids & do we have enough aids?
 - Charter budget pays for aid and district does as well
 - Currently three more aids are being processed
 - Also WHECES just hired a librarian, and the librarian is currently getting ready for the students

- Question portion of the evening ended, and the voting portion of the evening was to start
- Lilly Hill wanted it noted that the vote is cautioned because people staffed by LAUSD cannot vote
 - Eric Turner brought up that the bylaws are what we go by and it says any member can vote
 - \circ $\;$ He turned it over to the members about how to proceed
- The vote happened
 - 80% Yes
 - o 16% No
 - Programs will be going through
